The parent/guardian of successful recipients must maintain their employment with Extendicare Inc. for the duration of the award; specifically, at the time the fund is initially awarded and each renewal thereafter.

Should the employee leave Extendicare, the recipient will no longer be eligible to receive scholarship funds.

ELIGIBILITY REQUIREMENTS

Eligible employees must be currently employed by the company on a full or part-time basis, have retired from Extendicare, or are on an approved leave of absence. Applicants must satisfy the following requirements:

- Be the natural children, legally adopted children or stepchildren of Extendicare, Esprit, ParaMed and SGP employees
- Entering or already enrolled in an approved health care related postsecondary program in the year of their application
- Have maintained satisfactory academic standards in the last year for their program of interest and submit latest year's transcripts (secondary or post-secondary where applicable)
